### Rebate program update

Central Indiana Power's geothermal heat pump and air source heat pump rebate program ended Dec. 31, 2009 Rebate requests for eligible equipment installed before Jan. 1, 2010 must be submitted before July 1.

Electric Water Heater rebate program ended Jan. 31, 2010. Electric water heater rebate requests for eligible equipment installed before Jan. 31, 2010 must be submitted before July 1.

## New rebate program introduced for 2010

Central Indiana Power is establishing a new geothermal heat pump and air source heat pump rebate program effective July 1.

Rebate eligibility requirements for geothermal heat pumps and air source heat pumps installed after Dec. 31, 2009 will be finalized by July 1.

Geothermal heat pumps and air source heat pumps installed after Dec. 31, 2009, that meet the eligibility requirements under the new rebate program will be eligible for a rebate payment after July 1.

The new program will require submission of a rebate form and required documents to CIP's Energy Advisor, Darrin Couch for verification. Darrin can be reached at 477-2218 for more information.

# Scholarship applications

# One man's trash is ... another man's electricity?

Central Indiana Power's wholesale power supplier, Wabash Valley Power

Association, has added another landfill gas-toenergy (LFGTE) generating plant to its power



The completion of this project brings
Wabash Valley Power's total LFGTE
generating capacity to 36 megawatts
(MW). Via an exclusive arrangement with
Waste Management of Indiana, Wabash
Valley now owns 12 generating facilities
at seven landfills throughout the northern
half of the state.

Wabash Valley Power will also break ground on a 5 MW LFGTE plant in Elkhart County next month. Each plant uses Hoosier-manufactured Caterpillar engine-generators.

"Facilities like Liberty II produce enough electricity to power 3,500 homes, reported Keith Thompson, Vice President of Power Production for Wabash Valley Power. "The decomposition of garbage creates landfill gas, which is over 54%

methane gas. In most landfills, that gas is burned off, but with today's technology, we're able to transform that

into electricity," he explained.

In 2009,
Wabash Valley
became the first
Indiana company
to participate in
Green-e Energy
by offering a certi-

fied renewable energy option. According to CEO Rick Coons, "we pursue renewable generation whenever it makes good economic sense, because it's simply the right thing to do. By adding a Green-e certified product to our program, it further demonstrates our commitment to our members, to the environment, and to our industry."

Wabash Valley Power provides wholesale electricity to Central Indiana Power and 27 other electric cooperatives in Indiana, Illinois, Michigan, Missouri and Ohio, collectively serving more than 800,000 customers.
