Service under this schedule shall be single phase or multi-phase at NineStar’s available standard voltages. Single phase service shall be provided for any motors less than or equal to 10 hp. Multi-phase service shall be provided where motor capacity exceeds 10 hp. Total available transformer capacity will be less than or equal to 1,000 kVA. All electric service provided will be supplied through one meter.

**APPENDIX A**  
**PURCHASED POWER COST ADJUSTMENT**

The Power Cost Adjustment shall be billed, at the discretion of the Board of Directors, on a Power Cost Adjustment Factor, which shall be computed based on the following formula:

$$PCA = A + B + C$$

Where

PCA = The Power Cost Adjustment Factor.

A = The power supplier's quarterly wholesale fuel adjustment in \$ per kWh adjusted for line losses.

B = The power supplier's quarterly wholesale non-fuel purchased power adjustment in \$ per kWh adjusted for line losses.

C = The difference, per kWh sold, between the base rate purchased power cost from the power supplier in the current period and the base rate purchased power cost included in stated electric rate charges.

**APPENDIX B**  
**MISCELLANEOUS NON-RECURRING CHARGES**

**DELINQUENT RECONNECT FEE**

If electric service is disconnected for nonpayment a charge of \$50.00 must be paid before service will be restored.

**CHARGE FOR UNPAID RETURNED CHECKS**

When a check received in payment of a member's account is returned unpaid by the bank for any reason that is not the fault of NineStar Connect the account will be considered unpaid and subject to disconnect policy.

Each check returned to the Cooperative, by the drawee institution as unpaid for various reasons at the time presented for payment, will be assessed a handling charge of \$30.00 and shall be charged to the member in addition to any other charges assessed by the rate schedule.

**NON-AMI METER READING FEE**

A monthly meter reading fee of \$50 will be charged to all members requesting a meter that does not have remote meter reading capability.

**TAMPERING FEE**

A \$500 tampering fee plus attorney and court fees will be charged to the member for tampering with, altering, or accessing of any meter by unauthorized persons.
